

2	Eligibility to participate in the tender	: Organization/Contractor engaged in different horticultural construction work.
3	Estimated value for the work	: Rs. 144000.00 (Rupees one lakh forty four thousand) only
4	Earnest Money	: Rs. 4000/- (Rupees four thousand) only in the form of open Demand Draft/Deposit at Call Receipts drawn in favour of Deputy Director of Horticulture, Jalpaiguri from any Nationalized Bank
5	Security Deposit	: 10% of the value of "Work Order"

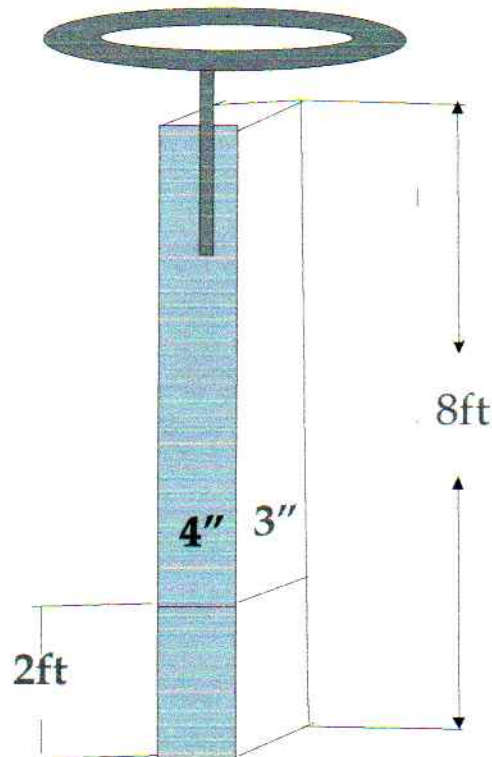
Terms and conditions:-

1. Successful Tenderer(s) shall have to execute an Agreement with the District Horticulture Office, Jalpaiguri on a Non-judicial stamp of Rs. 100/- (one hundred) only within the date specified in the letter of intimation. The cost of Non-judicial Stamp Paper of Rs. 100/- is to be borne by the willing tenderer.
2. The intending tenders shall have to furnish the copy of the documents related to PAN, Trade License, other related documents.
3. No tender will be accepted without Earnest Money.
4. The rate should be quoted on number basis and the rate of dragon fruit holding concrete Pillar with circle on the top will not exceed Rs. 720.00/- per piece with the total cost of 144000.00 only.
5. Each page of tender shall be signed by the tenderer before submission of tender Paper.
6. The kind of work must be written on the envelop.
7. Name & address of the tenderer and the item for which tender is to be deposited should be superscribed in block letters on the top of the envelop.
8. A Work order will be issued from the office of the undersigned and after accepting the same, the tenderer must start the work within stipulated time period as will be mentioned in the Work order, failing which his tender may be cancelled and earnest money will be forfeited. No hike of rates will be allowed later on.
9. The tenders, which do not fulfill any of the above conditions or incomplete in any respect, are liable to be summarily rejected.
10. The authority reserves the right to reject or accept any or all quotations without assigning any reason whatsoever.
11. The authority is not bound to accept the lowest quotation if found unsuitable. Acceptance / cancellation of the quotation will depend solely on discretion of the authority.
12. If the successful tenderer denies to accept the offer letter, his Earnest Money will be forfeited. In case of failure to fulfill the above said work at any point of time, his offer letter will be cancelled and Security Deposit will be forfeited without assigning any reason thereof.
13. In case of successful tenderer, the Earnest Money will be released after successful completion of the work.
14. In case of successful tenderer, the Security Deposit will be released after final payment of the bill.
15. In the event of quotation being submitted by a firm, it must be signed by each member thereof and in the event of absence of any partner, it must be signed on his behalf by a person holding a power of attorney authorizing him to do so.
16. The tenderer shall have to submit the attested photocopy of all related documents along with the tender paper.
17. All papers shall be verified with the originals.
18. Tenderer should complete the work as per required specification
19. No claim for any subsequent increase in market price of anything more than the rates offered / quoted by the tenderer shall be entertained.
20. The work includes the transportation cost up to Jalpaiguri Horticulture Research and Development Farm, Mohitnagar, Jalpaiguri.

The Specification of the Dragon fruit holding concrete Pillar with circle on the top to be supplied

Dragon Fruit Pole



1. Each Pillar height should be 8 ft.
2. Front & Back side length of wall thickness is 4"
3. Right and Left side wall thickness of the pillar is 3"
4. Each pillar should contain MS/GI circle on the top and from 6 " apart from the top level of the pillar to hold the dragon fruit branches
5. Each pillar should look like on the above image
