

TENDER NOTICE

Sealed tenders separate with rate of items are invited from the reliable and bonafide Producers/Supplier for the supply of Vermicompost for supply to the Farm at Mohitnagar, Jalpaiguri under Jalpaiguri Horticulture Research & Development Farm, Mohitnagar, Jalpaiguri. The tenders will be deposited in the tender Box kept in the office room of the Office of the undersigned.

1. Name of work / supply : Supply of Vermicompost
2. Contractors / Suppliers eligible to participate in the tender : **Producers/Supplier/Firm having experience of vermicompost supply to Govt. Office with credential of Rs. 50000/- during last 5 years**
3. Estimated value for supply of the items : Rs. 190000/- (Rupees one lakh ninety thousand) only
4. Earnest Money : Rs 5000/- (Rupees five thousand) only in the form of open Demand Draft/Deposit at Call Receipts drawn in favour of Deputy Director of Horticulture, Jalpaiguri from any Nationalized Bank
5. Security Deposit : 10% of the value of "Supply Order"
5. Time of Completion for supply : Within 7 days from the date of issue of the supply order.
6. Last date and time of dropping tender : 1.00 pm. of 18.12.2020
7. Date and time of opening of sealed tender : 2.00 pm. of 18.12.2020
8. Place of dropping tender : Tender Box kept in the District Horticulture Office, Jalpaiguri
9. Place of receipt of tender. : District Horticulture Office, Jalpaiguri Horticulture Research & Development Farm, Mohitnagar, Jalpaiguri from 16.12.2020 to 17.12.2020 between 11.00 am to 4.00 pm.

Supply of Vermicompost for supply to the Farm at Mohitnagar, Jalpaiguri under control of Assistant Horticulturist, Jalpaiguri Horticulture Research & Development Farm, Mohitnagar, Jalpaiguri

Terms & Conditions

1. Successful Tenderer(s) shall have to execute an Agreement with the District Horticulture Office, Jalpaiguri on a Non-judicial stamp of Rs. 100/- (one hundred) only within the date specified in the letter of intimation. The cost of Non-judicial Stamp Paper of Rs. 100/- is to be borne by the willing tenderer.
2. The documents like trade license, PAN card, income tax return will be submitted alongwith tender paper.
3. Only Vermicompost which is free from inert material like straw, sand, mud, vegetable husks, etc. will be supplied.
4. The vermicompost should have adequate moisture percentage at the time of supply. Anything found adverse regarding the moisture the weight of the vermicompost will be adjusted accordingly.
5. The rate should be quoted in such a manner that the amount of Vermicompost including transportation to the Farm at Mohitnagar, Jalpaiguri under control of Assistant Horticulturist, Jalpaiguri Horticulture Research & Development Farm, Mohitnagar, Jalpaiguri.
6. The rate should be quoted on weight basis, accordingly supply should be made in suitable bag/packet of 50 kg / 20 kg, so that, the volume of the vermicompost will be measured appropriately.
7. The rate of vermicompost will not exceed Rs. 9/- for 1 kg of vermicompost.
8. No tender will be accepted without Earnest Money.
9. Each page of tender shall be signed by the tender before dropping it.
10. Name & address of the tenderer and the item for which tender is to be deposited should be superscribed in block letters on the top of the envelop.
11. Supply of Vermicompost should be made to the Farm at Mohitnagar, Jalpaiguri under control of Assistant Horticulturist, Jalpaiguri Horticulture Research & Development Farm, Mohitnagar, Jalpaiguri with the own cost of the successful tenderer.
12. The tenders, which do not fulfill any of the above conditions or incomplete in any respect, are liable to be summarily rejected.
13. Payment will be made from the Jalpaiguri Horticulture Research & Development Farm, Mohitnagar, Jalpaiguri in such a manner that entire payment will be made after satisfactory delivery in proper quality and analysis of Govt. Laboratory, if necessary.
14. The authority reserves the right to reject or accept any or all tenders without assigning any reason whatsoever.
15. The authority also reserves the right to choose any kind of item or items.

16. The authority is not bound to accept the lowest tender. Acceptance / cancellation of the tender will depend solely on discretion of the authority and the authority is not bound to accept the lowest tender if found unsuitable.
17. No claim for any subsequent increase in market price of anything more than the rates offered / quoted by the tenderer shall be entertained.
18. In case of failure to complete the supply work within the stipulated time, the earnest money and performance security will be forfeited without assigning any reason thereof.
19. The Earnest money will be released to the unsuccessful tenderer after issuance of supply orders on application thereof.
20. A supply order will be issued from the office of the undersigned after accepting the same. Tenderer must supply the item within stipulated time period as will be mentioned in the supply order, failing which his tender may be cancelled and earnest money will be forfeited. No hike of rates will be allowed later on.
21. The Security Deposit in the form of Draft/DCR drawn in favour of Deputy Director of Horticulture, Jalpaiguri will be submitted at the time of agreement.
22. The Security Deposit Money will be refunded after successful delivery of the items and getting satisfactory field & testing report.
23. The tenders, which do not fulfill any of the above conditions or incomplete in any respect, are liable to be summarily rejected. Any deviation from the standard as required if found any time by the authority, the same will have to be replaced within specified time.
24. All papers shall be verified with the originals.
25. Deputy Director of Horticulture, Jalpaiguri reserves the right to issue tender Forms / Documents and accept or reject any tender thereof without assigning any reason whatever and not to be bound to accept the lowest tender.

Specification of Vermicompost to be supplied

Vermicompost material to be supplied should be retaining proper colour, moisture and free from any admixtures like, sand, soil, unwanted seeds, termites and or other pests and should contain appropriate quantity of organic carbon, nitrogen, phosphorus, potassium and other components as per scheduled norms.
