**Agenda I**

Discuss about the prayer of Miss Monika Dey, D/O Late Nikhil Dey, Paschim Arabinda Nagar, P.O. & Dist.- Jalpaiguri regarding route permit of Jalpaiguri, Cooch Behar & Darjeeling District for Tourist only in respect of the vehicle bearing registration No.WB71A8045.
