

**RESOLUTION OF THE RTA BOARD MEETING HELD ON 12.08.2016 AT 5.00 P.M.
IN THE CHAMBER OF THE DISTRICT MAGISTRATE, JALPAIGURI.**

Agenda I

In compliance to the order of Hon'ble High Court an opportunity of hearing was considered to the petitioner Shri Bipul Halder in the matter of W. P. NO. 11617(W) of 2015, Bipul Halder Vs State of West Bengal and others on 29/07/2016. To discuss the above said court matter.

Decision:-

The RTA Board considered the prayer of the petitioner and decided to reject the same on the ground that the route prayed for violates the Gazette Notification No. 268-WT/3M-01/2010-Pt.I dated 29/01/2010. The prayer of petitioner violated guidelines No. 3, 4 & 5 of the said notification. In the interest of the public safety road accident Traffic Congestion the RTA Board decided that no further permit cannot be granted at this stage.

Agenda II

To discuss the prayer of Shri Goutam Dutta, Secretary, Jalpaiguri & Alipurduar Tata Magic & Maxicub Owners Welfare Association regarding conversion to Stage Carriage Permit from Contact Carriage Permit due to Road Tax.

Decision:-

The Contact Carriage permits issued by the RTA, Jalpaiguri which covers from one point to another point vice versa. The permit in question covering one point to another point which always plies as a State Carriage permit follows the proper time table and proper fare. As such the owners of the contact carriage permit holder demanded to convert their Contact Carriage Permit to Stage Carriage Permit.

The neighboring district like Cooch Behar also issued same type of permit as a Stage Carriage which is similar with the permit issued by the RTA, Jalpaiguri paying lesser amount of Road Tax.

The RTA considered the prayer of Shri Goutam Dutta, Secretary, Jalpaiguri & Alipurduar Tata Magic & Maxicub Owners Welfare Association and decided to forward the application to the Transport Department, Govt. of West Bengal for necessary order regarding conversion to Stage Carriage Permit from Contact Carriage Permit.

Agenda III (i)

To discuss the prayer submitted by Shri Khokan Kumar Roy, S/O Nripendra Nath Roy of Fatapukur, P.O.- Fatapukur, Dist.- Jalpaiguri regarding the change of route from the existing " Bat tala to Maradangi via Belacoba" to "Bat Tala to Rajganj Kalinagar Hospital via Belakoba, Fatapukur". The applicant deposited fees of Rs.540/- against RVS402541 dated 26/08/2015.

Survey Report submitted by MVI(NT) :

As per Sub-Sec.(3) (i) & (ii) of Section 80 of MV Act. route can be extended or varied from this existing route. The applicant wishes to change the terminating point from Moradangi to Rajganj Kalinagar Hospital which is not permissible as per Sec. quoted.

Decision:-

The RTA Board considered the prayer of Shri Khokan Kumar Roy and rejected on the ground that the applicant wishes to change the termination point which is not permissible as per Sub-Sec. (3) (i) & (ii) of Section 80 of MV Act.

Agenda III (ii)

To discuss the prayer submitted by Shri Dilip Biswas, S/O Gopal Biswas of Rajadanga, P.S.- Malbazar, Dist.- Jalpaiguri regarding the change of route from the existing "Jalpaiguri to Malbazar via Borodhighi, Kumlai, Birpara, Lataguri, Banarhat" to "Jalpaiguri to Oodlabari via Kranti, Gangadebi, Malbazar" of his vehicle No.WB71-6198. The applicant deposited fees of Rs.540/- against RVS402744 dated 16/09/2015.

Survey Report submitted by MVI(NT) :

The applicant prayed for extension as well as diversion of the existing route. Diversion has been sought for more than 50 Kms. for the new route. As per Sub-Sec. 3(i) & (ii) of Section 80 of MV Act. minimum 24 Kms. of diversion may be allowed. Moreover existing route covers the remote areas like Borodight & Kumlai. Services to these areas would be hampered if diverted.

Decision:-

The RTA Board considered the prayer of Shri Dilip Biswas and rejected on the ground that the applicant wishes to extension as well as diversion of the existing route more than 50 Km. for the new route, which is not permissible as per Sub-Sec. (3) (i) & (ii) of Section 80 of MV Act. Minimum 24 Kms. of diversion may be allowed as per rule quoted.

Agenda III (iii)

To discuss the prayer submitted by Shri Tripurari Bishnu, S/O K. Tripurari of North Colony, Mal, Dist.- Jalpaiguri regarding the change of route from the existing "Naresh More to Oodlabari via E-Bye Pass, Ambari Gajoldoba" to "Mal to Oodlabari via Baradighi Kranti More" in respect of this office Memo. No. 740/MV dated 09/09/2015. The applicant deposited fees of Rs.540/- against RVS402730 dated 15/09/2015.

Survey Report submitted by MVI(NT) :

The original route starts from Naresh More near Bhaktinagar Police Station and terminates of Odlabari on NH-31C. The new route as applied starts from Mal and ends at Odlabari. This applicant wants to change this starting point from Naresh More to Mal which is more than 24 Km. It is about 50 Km. Moreover, the applicant has prayed for changing the starting point which cannot be allowed as per Sub-Sec.(3) (i) & (ii) of Section 80 of MV Act.

Decision:-

The RTA Board considered the prayer of Shri Tripurari Bishnu and rejected on the ground that the applicant wishes to change and also extension of the terminating point more than 50 Km, which is not permissible as per Sub-Sec. (3) (i) & (ii) of Section 80 of MV Act. Minimum 24 Kms. of diversion may be allowed as per rule quoted.

Agenda III (iv)

To discuss the prayer submitted by Shri Snehangshu Roy, C/O Smt. Sujata Roy of Raikotpara, Jalpaiguri regarding the route permit of "Jaikhana More to Bodaganj via Jalpaiguri Road Station" of Auto Rickshaw in respect of this office Memo. No.741 dated 09/09/2015.

Survey Report submitted by MVI(NT) :

As per resolution dated 28/08/2015 of the RTA, Jalpaiguri the applicant was requested to submit fresh application for consideration of his case. Instead he submitted the photocopy of the previous application without deposition any fees at present. Moreover he applied for auto-rickshaw (in his previous application with seating capacity of 7(I/D) but there is no auto-rickshaw with this type of seating capacity.

A Jalpaiguri Town area is already overcrowded with small passenger vehicles. Jaikhana more is already congested. Traffic-Jam is a regular phenomena. No more vehicles may be allowed to start from that point. Rather it may start from Gosala More.

Decision:-

The RTA Board considered the prayer of Shri Snehangshu Roy and rejected on the following ground :

1. The applicant has not submitted any new application with required fees.
2. The applicant applied for auto-rickshaw (in his previous application) with seating capacity of 7(I/D) but there is no auto-rickshaw with this type of seating capacity
3. The Jalpaiguri Town area is already overcrowded with small passenger vehicles. Jaikhana more is already congested. Traffic-Jam is a regular phenomena. No more vehicles may be allowed to start from that point.

Decision:-

The RTA Board considered the prayer of Shri Amaresh Barman and rejected on the ground that the applicant wishes to change of the terminating point as well as destination point from Salugara to Belakoba, which is not permissible as per Sub-Sec. (3) (i) & (ii) of Section 80 of MV Act.

To discuss the prayer submitted by Shri Madan Ghosh, S/O R.B. The applicant wishes to change the terminating point from “Check Post to Chowrangj More” instead of “Ektiysal T.A. Bidyalaya to Jatiakali More” which is not permissible as per Sec. quoted.

Decision:-

The RTA Board considered the prayer of Shri Madan Ghosh and rejected on the ground that the applicant wishes to change of the terminating point as well as destination point from Salugara to Belakoba, which is not permissible as per Sub-Sec. (3) (i) & (ii) of Section 80 of MV Act.




