1. The tenderers are requested to quote their rates in figures and words in the given proforma. The owner of the vehicle should quote the daily hiring charge taking into account driver's remuneration, food and lodging, maintenance and repairing charge and other incidental charge of the vehicle.

2. Copies of latest P.Tax, Service Tax, Trade License, PAN card have to be attached.
3. Tender should be submitted in sealed envelope superscribed with "Tender for Hire Vehicle for Disaster Management Section, Jalpaiguri" in the box kept in the Disaster Management Section, Jalpaiguri.
4. In the main envelope, there should be two separate envelopes containing the documents associated with the technical bids and financial bids. Only when an agency qualifies in the technical bids, will his candidature for financial bid be taken into consideration.
5. Prospective quotationers must be ready to place vehicle within 7 days from the date of acceptance of the offer letter. His taxi permit for the particular vehicle shall have to be produced within 60(sixty) days from the date of issue of acceptance letter otherwise, order will be treated as cancelled automatically.

Any other information will be available from the Disaster Management Section, Jalpaiguri.

The undersigned reserves the right to accept any rate at his discretion and does not bind him-self to accept the lowest rate of tender. It shall be open to the District Authority to impose penalty & take other punitive steps as deem fit, for violation of terms and conditions.

The last date of submission of tender is on 02.04.2018 upto 2.00 P.M. and the tender may be opened at 3.30 P.M. on the same day in presence of Agencies or their authorised representative at District Disaster Management Officers' Chamber (DDMO), Jalpaiguri.
