- On the day of opening of the tender, the Tenderers must be present with specimen copies of the terms and condition for which the rates were quoted.
- Prospective Tenderers must be ready to place vehicle within 7 days from the date of acceptance of the offer letter as well as taxi permit for the particular vehicle shall have to be produced within 30 (Thirty) days from the date of issue of acceptance of offer letter, otherwise order will be treated as cancelled automatically.
