3. Tenderers should be submitted in sealed envelope super scribed with "Tender for hire vehicle for RSBY & Swasthya Sathi Scheme, Health Section, Office of the District Magistrate, Jalpaiguri" in the Box kept in the Health Section, Ground Floor, office of the District Magistrate, Jalpaiguri.
4. Technical & Financial bids to be filed separately. Technical bids shall be taken into consideration first. Only after qualifying in the technical bid, the financial bids shall be considered.
5. On the day of opening of the tender, the quotationers must be present with specimen copies of the terms for which the rates were quoted.
6. Prospective quotationers must be ready to place vehicle/vehicle within 7 days from the date of acceptance of the offer letter as well as taxi permit for the particular vehicle shall have to be produced within 60 (sixty) days from the date of issue of acceptance of offer letter, otherwise order will be treated as cancelled automatically.
