Sealed Tenders are invited by the undersigned from the bonafide Contractors, Suppliers, Co-operative Societies/Registered SHGs having at least 2 years experience for Carrying and Storing of Food Stuff and other ICDS materials to different Anganwadi Centres under Rajganj ICDS Project ,Jalpaiguri .

Period of Issue of form :- 03/07/2017 to 24/07/2017 ( from 12 noon to 4 p.m on all working days )

Submission of tender form : 03/07/2017 to 25/07/2017 ( from 12 noon to 4 p.m on all working days except on 25/07/2017 upto 1 p.m)

Opening of Tender : on 25 /07/2017 at 3 p.m at Office Chamber of S D O Jalpaiguri Sadar , Jalpaiguri

**TERMS AND CONDITIONS FOR CARRYING:-**

1. The carrying will be made from Project Go-down to different Anganwadi Centres( sanctioned 523 AWCs) under this Project area and if necessary for any item return- carrying to Project go-down from any A.W. Centre.
2. Rate should be quoted both in figure and in words for per quintal (irrespective of distance) including loading and unloading charges and inclusive of all taxes and other charges.
3. Valid Vat/PT/IT clearance certificate, Trade License etc. valid for current financial year, **same related works Credentials for at least 2 years ( credential must not be more than 4 years old )** and self attested copy of PAN card to be submitted also. Without which the tender will be rejected.
4. Earnest money of Rs. 11000/-(Rupees Eleven thousand) only in the shape of DCR/NSC/Bankers Cheque/Bank Draft duly pledged in favour of the C.D.P.O. Rajganj ICDS Project should be enclosed with the tender papers without which the tender will be rejected.
5. Selected tenderer is to deposit Rs. 25,000/- (Rupees Twenty Five thousand) only as security money in the shape of DCR/NSC/Bankers Cheque/Bank Draft duly pledged in favour of the C.D.P.O. Rajganj ICDS Project and to execute an agreement bond on Non-Judicial Stamp paper worth Rs. 10/-(Rupees Ten) only within one month after getting approval from DLTC.
6. The contract period will remain valid for one year from date of signing the agreement.
7. The tenure of tender may be extended upto 6 (six) months or as desired by the authority and as per discretion of the PLTC if necessary and as per existing terms & conditions.
8. Carrying has to be completed within 14(fourteen ) days from the date of issue of carrying order and the materials to be delivered during working hours of Anganwadi Centres failing which necessary action will be taken against the Carrying agent.
9. Earnest money of successful but unwilling tenderer will be forfeited by the Tender Committee.
10. The carrying contractor is liable to carry food stuff and other ICDS materials throughout the year i.e. the contract period in approved rate or as desired by the authority and prayer for enhancement will not be entertained..
11. The carrying contractor will be solely responsible for loss or damage of food stuff or any other ICDS materials during transportation.
12. Payment will be made as per availability of fund.
