Due to non participation of any tenderer against this office NIT. 02 dt. 05.12.16 & NIT No. 03 dt. 16.12.16, 3<sup>rd</sup> time Marked Sealed Quotation are hereby invited from Interested Firms or Vehicle owners for Let out their Diesel run motor cab for official work of WBSSCL, Jalpaiguri Regional office within 2.00 P.M of 23.03.2017 through Regd. Poster or Dropping in tender box. Said quotation alongwith papers of vehicle & Driving License of Driver will be opned at 3.00 P.M. in this office on 23.03.2017.

**Terms & Conditions :**

- 1) Hire charge must be quoted in Rupee both in word & figure inclusive of all Taxes on per working day basis, mentioning vehicle no; date of manufacture, hire charge per working day & claim of service tax if any.
- 2) Fuel Consumption rate is fixed for Diesel 12 Km/liter & Mobile 500 Km/liter basis which is reimbursable in 1<sup>st</sup> week of succeeding month as per existing rate on production of cash-memo of fuel filling station. i.e. Vehicle owner will have to bear consumed fule cost primarily & will re- imbursed said cost during bill payment.
- 3) Marked sealed rate quotation alongwith self attested copy of valid PAN Card, Road Tax clearance, Rout Permit, Blue Book of Car, Pollution Control Certificate, Insurance Coverage, Driving License of Driver must be reached in this office within 2.00 P.M. of 23.03.2017. Besides this, incase of Firms self attested copy of Valid Trade License, Prof. Tax deposit challan, Service Tax Regn. are also be enclosed alongwith quotation. The said quotation will be opened at 3.00 P.M. on 23.03.2017 in this office only in presence of participated quotationers.
- 4) Diesel run commercial vehicle owner will get first preference if the hire charges permit within the exiting notification no. 3564-WT/3M-81/98 dt. 24.11.08 of Transport authority, Govt. of W.B.
- 5) Haltage charge, Demmaurage & Repairing Cost of vehicle, accidental risk etc. will not be broned by this corporation. For extra time work beyond 10 hrs. duty will be allowed to vehicle owner as per rate of existing G.O. of Transport Authority on monthly basis during bill payment.
- 6) The authority reserve absolute right to hire vehicle from open market at any rate if vehicle owner fails to place vehicle in scheduled time before 2 hrs. requisition as in emergent period and said bill amount with be deducted form the bill of vehicle owner.
